Sir,

References above, Consortium of The Jana Enterprise (Lead Member), Bhranti Bhusan Singha (Non- Lead Member 1) and Siddhanath Enterprise (Non- Lead Member 2) has been selected as L1 Bidder for establishment of centralized mechanized laundry at Malda MCH and the LOA issued to the Selected Bidder. As per the clause 2.1.13 of the RFP, the Selected Bidder shall need to form a Special Purpose Vehicle (SPV) for signing of the agreement. The agreement shall be signed between Hospital Authority (where the centralized mechanized laundry units will be set up) and SPV and representative from DoH&FW, GoWB.

A draft agreement is hereby attached for signing. Same has to be signed with proper performance security by way of submission of Bank Guarantee as per clause 9 of the agreement. Draft agreement with all details after discussion with hospital authority has to be placed before Secretary PPP, for the final date of signing at department level between Hospital Authority, MSVP/ Superintendent (where the centralized mechanized laundry units will be set up) and SPV and representative from DoH&FW, GoWB.
