
And whereas Approval of commissioning of the unit issued vide Memo No.: HFW-14099(14)/2022-SPSRC SEC Dept. of H&FW/PPP/1805 Dated: 14/10/2022 and unit allowed to be made functional for patients services,

And whereas prayer has been received from NDDM vide memo no. NDDM/ESTT/7133, dated 07/11/2022 to the department with a request to either modify the agreement by deleting the clause where RKS (Rogi Kalyan Samiti) is appearing or modify the conditions in the administrative approval issued,

Now after due consideration of the prayer, it has been decided that the agreement will be quadripartite in nature with Rogi Kalyan Samity (RKS) of the Hospital Authority, North Dum Dum Municipality (NDDM) and selected H-1 Bidder being the other three signing parties.

All other Terms and Condition of the Agreement, duly concurred by FD **vide Group-T/2022-2023/0145 UO date 13/05/2022** will remain same.

Accordingly the agreement may be executed at the earliest.
