So, due to non-availability of sufficient bidders as per norms the tender selection committee unanimously decides not to open the received bids for the aforesaid 4 (four) nos of e-tenders. The committee further decides to declare e-tender for Repair & Renovation work for HWC (Civil) at 4 (Four) nos of sub centers i) Laxmidanga SC ii) Nrishingahpur SC iii) Nawapara PHC iv) Shimulgachi SC as cancelled.
