

Financial bid evaluation summary in connection with re e-tender for procurement of Bio-safety cabinet vide this office Memo No.-CMOH-Nad/9102, dt.-05/10/2018:

On opening of financial bid submitted by Aisha Enterprise, it appeared that they had quoted Rs. 189786/- (one lakh eighty nine thousand seven hundred and eighty six) which is 29.43% (twenty nine point four three percent) below than Rs. 2, 68, 926/- (two lakh sixty eight thousand nine hundred and twenty six) (shown as estimate in re e-tender vide Memo No.- CMOH-Nad/9102, dt.-05/10/2018).

So, in terms of norms laid down vide No.-6989-F(Y), dt.-19/11/2018 of the Finance Department, Audit Branch, Govt. of West Bengal, prayer for approval for acceptance of rate quoted by the only technically successful bidder letter was sent to state vide Memo No.-CMOH-Nad/10735, dt.-20/12/2018 along with information as per annexure of No.-6989-F(Y), dt.-19/11/2018.

Now, as the office has received No.-141-HF/O/PHP/3C-03/2018, dt.-12/03/2019 of the Dy. Secretary, PHP Branch, Govt. of West Bengal allowing the tender inviting authority to procure the bio-safety cabinet, the tender selection committee unanimously decides to accept Aisha Enterprise as the successful bidder with their quoted rate i.e. Rs. 1, 89, 786/- (one lakh eighty nine thousand seven hundred and eighty six) (including all applicable taxes and charges).


