Technical bid evaluation summary in connection with e-tender for security service for Hospitals of Nadia district vide Memo No.-CMOH-Nad/10408, dt.-22/12/2017

Findings noted by tender selection committee regarding the above mentioned tender is as follows:-

**Bhagirath Ghosh-**

The amount of work done has not been mentioned in the credential certificates. Undertaking (clause No. 13 under Section VI: General Instruction to Bidders of terms & conditions of tender) has not given in required format i.e. the non-conviction status of employee was not included. Although, the issue of EPF submission for less than 20 employees can be considered in favour, but the credential certificate is not issued from any institution (required as per clause 3 under Section V: General Conditions of Contract of terms & conditions of tender), but from an individual and from the last e-tender he had been refusing to give clear proof of credit of the payment as well as tax deduction details relating to the work mentioned in credential certificate to the tender committee for clearing the doubt and proving genuineness of the credential in question and since this attitude of the bidder had already been declared condemnable by the appropriate authority and since the same controversial credential has been used in this re-tender also, the committee decides to reject it & go for further action if required later on.

**M/s Debnath Construction:**

Tender No. has not been written in the proforma for performance statement. Undertaking (clause No. 13 under Section VI: General Instruction to Bidders of terms & conditions of tender) has not given in required format i.e. the non-conviction status of employee was not included, EMD not submitted in the way as described in terms & conditions of tender (clause No.4 under Section V: general Conditions of Contract of terms & conditions of tender).

**General Security & Information Service:**

Whether online EMD was submitted in the tender in the way as described in terms & conditions of tender (clause No. 4 under Section V: general Conditions of Contract of terms & conditions of tender) is not clear from application. Undertaking (clause No. 13 under Section VI: General Instruction to Bidders of terms & conditions of tender) has not been given in required format i.e. the non-conviction status of Proprietor was not included. The bidder did not submit any proof to clarify about different types of signatures done in his name on the submitted papers, in spite of written request from the tender committee vide Memo No. CMOH-Nad/1947, dt.-28/02/18. This amounts to non-cooperation on the part of the bidder raising suspicion about the genuineness of the signatures authenticating the documents. The bidder did not upload last GST return (GST return submitted of September, 17).

**M/s Hero Enterprise:**

Did not submit credential for security as required in the tender (required as per clause 3 under Section V: General Conditions of Contract of terms & conditions of tender). Undertaking (clause No. 13 under Section VI: General Instruction to Bidders of terms & conditions of tender) has not given in required format i.e. the non-conviction status of employees was not included.





**Zoom Enterprise:**

Did not upload last GST return (GST return submitted of November, 17). Notary not done in the page for proforma for performance statement. Whether online EMD was submitted in the tender in the way as described in terms & conditions of tender (clause No. 4 under Section V: general Conditions of Contract of terms & conditions of tender) is not clear from application

**M/s Indian Traders:**

Notary not done in the page for proformawise performance statement (contradictory to our Memo No.-CMOH-Nad/401, dt.-15/01/18), EMD not submitted in the way as described in terms & conditions of tender (clause No.4 under Section V: general Conditions of Contract of terms & conditions of tender).

**M/s Neogi Construction & Co.:**

Notary not done in the page for proforma for performance statement. Information (i.e. credential amount) does not match in proforma for performance statement & credential. Undertaking (clause No. 13 under Section VI: General Instruction to Bidders of terms & conditions of tender) has not been given in required format i.e. the non-conviction status of employee) was not included. Last GST return not submitted (GST submitted of November, 17).

**The Jana Enterprise:**

Did not upload last GST return (GST submitted of November, 17), Submitted proformawise performance statement is not notarized. Whether online EMD was submitted in the tender in the way as described in terms & conditions of tender (clause No. 4 under Section V: general Conditions of Contract of terms & conditions of tender) is not clear from application.

**Royal India Securitaus:**

Wrong tender no. & date written in the tender application form, 2 bank solvency certificates uploaded, proformawise performamce statement not given, **last GST return not submitted (GST payment receipt with deposit dt.-5/10/17 submitted)**. One bank solvency certificate with date 13/12/16 submitted which was previously used in security tender vide Memo No.-CMOH-Nad/7004, dt.-10/8/17. But, no application for reuse of same bank solvency certificate as mentioned in pre-bid minutes vide Memo No.-CMOH-Nad/401, dt.-15/01/18 has been submitted by the vendor. Another bank solvency certificate with dt.-11/08/17 submitted but it is not as per clause (clause No. 12 under Section VI: General Instruction to Bidders of terms & conditions of tender) mentioned in notice inviting tender. Required undertaking (clause No. 13 under Section VI: General Instruction to Bidders of terms & conditions of tender) has not been given.

**Command Security Service:**

Solvency certificate is of the date 24/10/17 which is not as per terms & conditions of tender (clause No. 12 under Section VI: General Instruction to Bidders of terms & conditions of tender). Notarized credential certificates of work has not been given (as mentioned in Memo No.-CMOH-Nad/401, dt.-15/01/18). Last GST return not submitted (GST submitted of November, 17), Submitted Balance sheet for FY 16-17 not audited.


**Ex-Serviceman Security Service & Allied:**

Wrong tender no., Memo & date given in submitted proformawise performance statement (dt.-6/9/17). Given credential of work is not notarized (as required in Memo No.-CMOH-Nad/401, dt.-15/01/18). Last GST return not submitted (GST return submitted of November, 17).
