Reference above it may be noted that the current Renewal agreement for DR Service under O&M model at your hospital, presently managed By Dreamland Nursing Home is deemed to expire on 13-05-2023.

Now as per request by partner regarding non-continuation of services and confirmation from your end that all dues on either side are cleared till date, approval is hereby granted for discontinuation of service in PPP mode and termination of current agreement for DR Services between Superintendent Balurghat DH and Dreamland Nursing Home based on following conditions :-

- 1) Hospital authority will ensure that the partner have cleared all legitimate dues in respect to concession fees and electricity bills and any other dues if applicable, for the entire period of the agreement, till the date of handover of Unit to hospital.
- 2) "In case of non-payment, the performance security in form of Bank Guarantee may be suitably invoked if required. Similarly dues by the Hospital for services rendered may be cleared only after the partner clears all his due following existing financial norms.
- 3) The handover of the DR Unit back to hospital authority may be done in presence of concerned hospital officials, PWD and BME of the district and the procedure duly recorded. Only after proper handover may the partner be allowed to discontinue running agreement. A suitable date for handover may be decided mutually.
- 4) The Digital X ray unit will henceforth run in department mode by in-house manpower and logistic as well as CAMC support will be provided as per departmental norms.
- 5) Necessary Communications may be made from your end to the partner in this regards.
