Financial bid evaluation summary in connection with etender for procurement of spectacles and black goggles vide Memo No. CMOH-Nad/PH/NPCB/1944, dt. 26/02/2019:

On opening of financial bids, it appeared that for Part A; Gita Optical, Jahirul Haque Biswas, Sanjay Kumar Misra had quoted Rs.180/-(one hundred and eighty) for each spectacle. So, there is a tie among these 3 (three) bidders for Part A.

For Part C, Gita Optical, Jahirul Haque Biswas, Sanjay Kumar Misra had quoted Rs. 335/-(three hundred and thirty five) for each spectacle. So, there is a tie among these 3 (three) bidders for Part C.

Now, the tender inviting authority has received an affidavit dt. 31/05/2019 from Sri Tapan Sarkar on behalf of Gita Optical, Mr. Jahirul Haque Biswas, Sri Sanjay Kumar Misra. In this affidavit, all of these 3 (three) bidders have placed prayer for equal job distribution for Part A, Part C of this etender. In this affidavit, they have mentioned that if the tender inviting authority decides to issue supply order to any of these three (3) bidders for any number of spectacles for any zone, they do undertake that none of them will have the right to complain against that and the tender inviting authority will reserve the right to issue any amount to anyone. No court case will be done by any of these three (3) bidders and no case would stand therefore.

They have also proposed plan of region selection bidder wise for Part A & Part C of this etender as per following

- 1) Gita Optical-District Hospital, Nadia, Chakdaha BPHC, Bagula RH, Sanipur SGH & Fulia BPHC (under Santipur Block), Haringhata BPHC & Nagarukhra PHC under Haringhata Block, Jadavdutta BPHC, Bishnupur BPHC
- 2) Jahirul Haque Biswas-JNM Hospital, Ranaghat SDH, Natidanga BPHC, Chapra BPHC, Kaliganj BPHC, Debagram PHC, Dhubulia BPHC, Aranghata BPHC, Dharmada PHC
- 3) Sanjay Kumar Misra- Tehatta SDH, Nabadwip SGH, Karimpur RH, Pritimoyee RH, Bethuadahari RH, Maheshganj RH, Krishnaganj RH, Badkulla PHC

The tender selection committee members unanimously decide to accept the above mentioned region selection for these 3 (three) bidders for both Part A & Part C of this e-tender with their quoted rate per unit & issue letter of acceptance/ supply or work order accordingly.

However, for Part D of this e-tender, on opening of financial bid, it appears that Gita Optical, Asish Singha, Jahirul Haque Biswas, Sanjay Kumar Misra have quoted Rs.24/-(twenty four) for each black goggle. So, there is a tie among these 4 (four) bidders for Part-D.

In the affidavit submitted by Tapan Sarkar on behalf of Gita Optical, Jahirul Haque Biswas, Sanjay Kumar Misra, they have requested for lottery in Part-D.

So, the tender selection committee decided to go for draw of lots.


Through draw of lots, Asish Singha has been selected as the successful vendor for Part-D of this etender. So, the tender selection committee unanimously decides to accept Asish Singha for Pat-D of this etender with his quoted rate.

The tender selection committee also decides to select Gita Optical as the 1st runner up, Jahirul Haque Biswas as the 2nd runner up & Sanjay Kumar Misra as the 3rd runner up through draw of lots for Part-D of this tender.

The tender selection committee also decides to accept Gita Optical, Jahirul Haque Biswas and Sanjay Kumar Misra for the region mentioned in previous page for both Part A & Part C of this tender. However, the tender selection committee also mentions that Chakdaha SGH has been missed in the distribution matrix which is also being offered to Gita Optical for both Part A & Part C, which they failed to mention. To be noted that the final decision regarding distribution however is kept reserved with the Programme Officer, NPCB, Nadia as per satisfactory performance of the vendors.

Hence, letter of acceptance/ supply order may be issued as proposed above.

The tender selection committee also took decision to the effect that tender may be invited for Part B of this tender.


