

Technical bid evaluation summary in respect of e-tender for construction of common collection site at Bethuadahari RH, Nakashipara Block & Karimpur RH, Karimpur-I Block vide CMOH Office, Nadia Memo No.-CMOH-Nad/2185, dt.-09/03/18:

On opening of e-tender, it appears that no bid is submitted for construction of common collection site at Karimpur RH, Karimpur-I Block, Nadia. So, this e-tender for construction of common collection site at Karimpur RH vide tender ID No. 2018_HFW_162466_2 of www.wbtenders.gov.in is hereby cancelled.

Two bidders namely Mondal Enterprise & M/s Maa Enterprise has submitted their bid for construction of common collection site at Bethuadahari RH. On opening of technical bid, it appears that Mondal Enterprise has not submitted audited Profit & Loss A/c & balance sheet for FY 15-16 & 16-17. He also did not furnish schedule of Bank Accounts. Mondal Enterprise did not qualify technically.

M/s Maa Enterprise has submitted all the required documents except schedule of Bank Accounts. But, he has submitted one statement of Account for the month September, 2016 & another illegible statement. M/s Maa Enterprise submitted audited balance sheet of FY 15-16 which has schedule of Bank Account. So, M/s Maa Enterprise qualifies technically as per norms written in Memo No.-925-F(Y), dt.-14/02/17, ^{of Govt} So, financial bid of M/s Maa Enterprise will be opened on 30/05/18 at 2:00 p.m.
