OPD on **30.11.2021** (Tuesday) at **11.30 A.M.** for their medical examination, vide memo no. 1809-P.S.Cell/HR/O/3P-11/2021, dt. 17.11.2021, of Home & Hill Affairs Dept., Govt. of W.B., Police Service Cell, Writers' Buildings, Kolkata-700001.

The list of above mentioned candidates is enclosed herewith the notice.

They may be requested to deposit a sum of Rs. 25/- (Rupees Twenty Five) only to the Reserve Bank of India or in Government Treasury or through online (www.wbfin.gov.in) in T.R. Form-7, in duplicate under receipt head "0210-Medical & Public Health-01-Urban Health Service-800-other Receipts-001-Collection of Misc. Service Fees-14-Service Fees" (A/C Code 0210-01-800-001-14) and obtain a copy of receipt of the same for submission to the Medical Board with an additional amount of Rs. 75/- (Rupees Seventy Five) only in cash being the medical Examination Fees.

They are also requested to bring the following documents for submission at the Medical Board.

1. A certificate from a competent Eye Specialist showing the current condition of eyes. If there be any error then power of lens/glass should be mentioned. A candidate even with slightest error must wear correction glass/lens to show it before the Medical Board.
2. A pathological report of Urine (R/E) from any competent pathologist, wherein the specific gravity, albumin, sugar, cast and cells of urine should be categorically mentioned.
3. X-ray Report of Chest with plate from a competent radiologist.
4. Two recent passport size photographs.
5. One address proof with photo I.D with one self attested photo copy of that I.D. and photocopy of the selection letter.
6. Original P.H. certificate along with one self attested photo copy of that certificate if the candidate is physically challenged.


