Service Fees-14-Service Fees" (A/C Code **0210-01-800-001-14**) and obtain a copy of receipt of the same for submission to the Medical Board with an additional amount of Rs. 75/- ( Rupees Seventy Five) only in cash being the medical Examination Fees.

They are also requested to bring the following documents for submission at the Medical Board.

1. A **certificate from a competent Eye Specialist [Ophthalmologist]**, Medical Registration Number to be mentioned] showing the current condition of eyes. If there be any error then power of lens/glass should be mentioned. A candidate even with slightest error must wear correction glass/lens to show it before the Medical Board.
2. A **pathological report of Urine (R/E)** from any **competent pathologist**, wherein the specific gravity, albumin, sugar, cast and cells of urine should be categorically mentioned.
3. **X-ray Report of Chest** with plate from a competent **radiologist**.
4. **Three (3)** recent passport size photographs.
5. One address proof with photo I.D with one self attested photo copy of that I.D.
6. Admit card of the examination/Selection letter - both original and self attested photocopy.
7. Original P.H. certificate along with one self attested photo copy of that certificate.
8. **ECG (in all leads)** report from a **Cardiologist**.
