NOTIFICATION

In reference to the Recruitment Notice No.:SHFWS/2022/255, dated: 22.06.2022, the following B.Sc./ Post Basic B.Sc. Nursing candidates passed with Integrated BPCCHN Course are hereby selected for the position of 'Community Health Officer (CHO)' under National Health Mission on contractual basis.

The mentioned candidates in the list attached will hereby engaged as per the terms and condition mentioned below:

- The posting as CHO will be done through merit cum choice counseling for placement in any Su-Sasthya Kendra in the State of West Bengal, as per vacancy / requirement.
- They will get a consolidated monthly remuneration of Rs.20,000/- (Rupees Twenty thousand) only. In addition the CHOs may also get a maximum incentive of Rs.15,000/ per quarter as PLI on sound assessment system as per parameters defined by the Department.
- The period of contract will automatically get terminated at the end of the current financial year and it will be renewed in subsequent financial years as per NHM norms.
- The service may also be terminated by one month's notice from either side.
- If the incumbent proposes to give up his/her work without covering 01 (one) month notice period, his/her remuneration will be deducted accordingly.
