2. A pathological report of Urine (R/E) from any competent pathologist, wherein the specific gravity, albumin, sugar, cast and cells of urine should be categorically mentioned.
3. X-ray Report of Chest with plate from a competent radiologist.
4. Two recent passport size photographs & one address proof Photo I.D. card with one self attested photo copy of above I.D. and photocopy of Selection Letter.
