
1. **Letter of Offer** to the selected agency / farm will be issued shortly with request to **deposit Performance security worth Rs. 3,00,000.00 (Three Lakhs) only through Treasury Challan under the budgetary head of account "8443-00-103-Earnest Money-01-07-Deposits"**. After obtaining **acceptance letter** from the selected farm and **deposition of Performance Security** by the said farm a **bond or contract** will be signed between **the selected supplier / agency / farm and the purchaser / Tender Inviting Authority. Award of Contract / Work Order** will be issued thereafter.
2. **The rate of supply of cooked diet and terms and conditions of the contract will be the same as mentioned in the Tender and as referred in the G.O. No. 18(2)-MS/HF/O/MS/W-06/2017 Dated-15.01.2018.**
3. The period of contract and Work Order will be initially for a period of 01 (one) year from the date of issue of this notification. The period of contract or Work Order may be extended for further 02 (two) years on yearly basis subject to satisfactory performance of the supplier. Hence, the total period of contract will be for 03 (three) years (1 yr + 1 yr + 1 yr) basis.
4. The purchaser or the Tender Inviting Authority reserves the right to extend the contract by another 03 (three) months on same terms and conditions at the end of 03 (three) years' contract period. Thereafter, the contract period may be extended on same terms and conditions for further periods on mutual agreement between the purchaser and the contractor.
5. The Performance Security shall be retained up to 06 (six) months after the date of completion of all contractual obligations by the contractor. In the event of failure / default / of the contractor with or without any quantifiable loss to the health facility / purchaser/ Government, the amount of the Performance Security will be forfeited by the health facility/ purchaser/ administrative Department/ Government.
