Sub: Verification of documents and Medically Fit Certificate for admission of the provisionally Selected candidates to G.N.M. Training course for the session- November 2020 –October 2023 and ANM(R) Training Course for the session: November 2020 – October 2022.

This is to inform that the panel of the provisionally selected candidates (reserved and unreserved candidates including orphan, Civil Defence, PWD and EWS candidates) for admission to G.N.M. Training Course for the session- November 2020 –October 2023 and ANM(R) Training Course for the session- November 2020 – October 2022 have duly been approved by the undersigned available in the website www.wbhealth.gov.in.

This is further to state that the admission to the said training course is subject to the fulfillment of the following conditions:

- a) Each of the candidates provisionally selected for G.N.M. training course/ ANM(R) Training course to be called for provisional verification will have to bring filled up Medically Fit Certificate from a Registered Medical Practitioner having at least MBBS degree and Residential Certificate in the prescribed formats (to be downloaded by the candidate from the brochure in the web site) and the call letter(to be downloaded by the candidate from the web site).
If any candidate (Female) is provisionally selected for both G.N.M. training course/ ANM(R) training course, their candidature will be verified for both courses in the verification centre as per prescribed district. Finally, she will be admitted for any of the single course as per her choice.
- b) If the provisionally selected candidates fail to turn up on the specific date with requisite papers and documents, the candidature will be cancelled automatically.
- c) The candidature of a candidate will be cancelled if he/she is found medically unfit as per norms.
- d) All the original certificates and mark-sheets of the Higher Secondary or equivalent Exam will be verified on the verification date. The verification of certificates and mark sheets are to be strictly followed according to the Annexure I,II,III,IV& V.


Following Certificates to be verified strictly:

- Age Proof Certificate (Madhyamik Admit Card or equivalent Certificate)
- Mark Sheet (Higher Secondary or equivalent Examination)
- Residential Certificate (as per to format)
- Caste Certificate
- Certificate related to Orphan
- Certificate related to CD
- Certificate related to PWD
- Certificate related to EWS (as per to format)
- Medical Fit Certificate (as per to format)

- e) The candidates will be debarred from the training course provided the mark sheets of the Higher Secondary or equivalent examination they had earlier submitted does not tally with the records of the concerned Council /authority of Higher Secondary or equivalent Examination.
- f) The eligible and medically fit candidates will get the printed verification completion certificate from the concerned verification centre only.
- g) Each candidate should submit a written undertaking to the effect that: -
- i) She/he will submitted a written undertaking regarding marksheet (as per format attached).
 - ii) She/he will abide by the rules and regulations of the W.B.N.C. as well as the local institution.
 - iii) She/he will pay Rs. 12/- (Rupees Twelve) only per month as Seat Rent for accommodation in the Hostel and she will bear the Messing Charges out of her/ his own in the institution where she/ he will be admitted.

The candidates must take admission at the institution as per Schedule date mentioned at the brochure, after which no request for admission will be entertained. The commencement of the course will be from **03.11 2020**.

The Joining Report of the candidates must reach the office of the Jt. D.H.S. (Ng.), West Bengal by **31st December, 2020** indicating their names, father's Name, Panel No. (With name of the Dist.), Caste, Date of Birth and Date of Joining. The self-attested photocopies of their Admit Cards must be enclosed with their joining reports.

In accordance with the Ministry of HRD OM No. 2-35/2011-Sch.3 dated 07.09.2012 and OM No. 14021/1/2012-Estt.D dated 06.03.2013 of the Ministry of Personnel, PG & Pensions, DOPT, the Council of Boards of School Education in India (COBSE) is responsible for verifying genuineness/recognition of school education boards in India. It grants membership to boards/institutions that are set up by an Act of Parliament or State Legislature or By an Executive Order of the Central/State government, and broadly following the National Curriculum Framework/ CBSE. On the basis of this, the genuineness of a board can be concluded. The certificates issued by its member-boards are equivalent to any other board across the country.

On verification of the records maintained in COBSE office, we find that the name of the **Akhil Bharatiya Mukta Vidyapith, Uttar Pradesh; Naba Bharat Siksha Parisad (NSP), India; Board of Higher Secondary Education, Delhi; All India Santali Education Council, and Board of Secondary education, Madhya Bharat, Gwalior (M.P.)** do not appear in the list of member-boards of COBSE. Therefore, the certificates issued by these Boards/ Council cannot be given equivalence for employment in Central/ State government organizations or for pursuing higher studies.
