



Subject: Re-Tender/ 2nd. call of tender for Supply of Cooked diet to inpatients of Secondary and Tertiary Tiers of Govt. hospitals

Sir/ madam,

Questions are being raised regarding Re-tender /2nd. Call for supply of cooked Diet to the inpatients of Govt. Hospitals under Dept. of H & FW, Govt. of West Bengal.

Some clarifications are being given regarding such controversies.

1. As per Clause No. 4 of the original bid document, Registered SSI units participating in Govt. tenders are eligible for exemption of payment of Earnest money and security deposits under Rule 47A(1) and Rule 47B(7) of WBFR.
2. As per clause No. 12.3- 'Non Statutory cover to contain following documents ...', it is *One Time Procedure* for submission of solvency certificates. So, bidders, who had submitted the Bank Solvency Certificates during the Primary e-Tender for such supply of cooked diet in districts/ Medical College & hospitals/ Decentralised Govt. hospitals in January, 2018, anywhere within the state, are not to submit fresh Bank Solvency Certificate, rather the earlier one will be accepted.
3. The amount involved as financial credibility for supply of cooked diet by the successful bidders, who have been engaged in hospitals/ MCHs as per the original tenders during January, 2018 i.e. effective from October, 2018, will be deducted from the solvency credibility in this retender/ 2nd. Call.
4. Necessity for submission of GST certificate/ No. will be governed as per latest GST norms.
5. Eligibility criteria as per Clause 3.1 of 'Section VI General Condition of Contract', the tenderer are to have experience of such nature work for three years during period after April, 2011 till end of September, 2018.


