Reference above, order has been issued from time to time for proper fund management and timely payment of services in relation to Fair Price Diagnostic (CT scan, MRI, Digital X Ray, PET Scan, Audio Vestibular Clinic) and Dialysis Service, with necessary guideline for utilization of funds. At present funds are provided from both state budget and NHM.

Similarly order has been issued related to key observations in PPP contract management and necessary guidelines to be followed in case of contract default. Notification related to waiver/reduction of concession fees has also been circulated with instructions.

4. District Accounts Manager.


