Please note that, as there are 8 (eight) L1 bidders have been financially qualified in respect of Belur SGH & Satyabala IDH and 9 (nine) L1 bidders have been financially qualified in respect of South Howrah SGH, Fort Gloster SGH & Udaynarayanpur SGH each, it has been unanimously decided to select only 1 (ONE) L1 bidder for each SG Hospital. For selection of 1 (ONE) L1 bidder out of financially qualified L1 bidders, Lottery method was conducted by the Purchase Committee Members and representatives all L1 bidders who participated in the meeting on 12.11.2021. Separate Lottery was conducted for each hospital and the representatives from all the L1 bidders present at the venue, participated in the Lottery Process. The representatives of L1 bidders who were absent on the same day were also considered in equal probability and chances in the aforesaid 'Lottery Draw'.
