Circular for Round 2 reporting State Quota and Private Management Quota UG Medical and Dental seats in West Bengal 2017

Eligible candidates who will be allotted seats through online counseling in Round 2 State Quota and Private Management Quota UG Medical and Dental seats in West Bengal 2017, have to report to the allotted institutes for admission in Round 2 between the time frame 21 August 2017 till 25 August 2017 (from 10 am till 4 pm on all the days as mentioned as per server time).

Candidates who are newly allotted in Round 2 will report to the allotted college directly with the ONLINE ALLOTMENT letter of Round 2 and the documents in original and one copy of self attested photocopy (as stated in the Frequently asked questions in the website www.wbmcc.nic.in).

On the contrary, the candidates who are upgraded from one college to another or category upgraded in the same college (for category candidates) have to first report to the previously admitted college with the ONLINE ALLOTMENT Letter of Round 2 for ONLINE RELIVING letter which will be generated by the reporting officer through the Reporting officer's manual and password online.

After generating ONLINE RELIVING letter, the college will return the original documents to the candidates along with the tuition fee and caution deposit while admission fee will be forfeited. For State Govt College to State Govt college upgradation, no need to refund the fee as the candidate is allowed to take admission in the newly upgraded college by showing the fee receipt of the previous college. After returning the original documents to the candidates the college will take back the original **receipt of deposition of documents** with the college issued to the candidate early on.

Upgraded candidate is now allowed to move to newly upgraded college for online reporting and generation of ADMISSION letter, deposition of fee or receipt (as the case may be) and deposition of documents as like previous round within the stipulated time frame stated earlier in this circular.

Category upgraded candidates in the same college must also take online reliving and re admit themselves through online reporting.

Online reporting of upgraded candidate in newly upgraded seat is not possible unless online reliving is done by the previous college.

Another important issue is **online surrender** of admitted candidates if not satisfied with the admitted seat. This is available from 10 am to 4 pm daily between 21 August 2017 till 25 August 2017 at the college where the candidate is at preset admitted. **This is possible only through College**

admin ID and password by the college authorities after receiving application from the admitted dissatisfied candidate.

It must be remembered by the candidate and the college that **candidate who surrender the seat are out of the counseling process and cannot take part in the manual counseling scheduled later on.**

Both for the upgraded and the newly allotted candidates the **willingness for subsequent manual round** will be taken during online reporting at the newly allotted or upgraded college. Such admitted candidates who do not opt for manual round cannot go for manual round later on.

If a registered candidate (after payment) is not allotted any seat in Round 1 or Round 2, he/she is allowed to participate in the manual round. **If any allotted and admitted candidate in Round 2 expresses willingness for upgradation in manual round then also he/she is eligible to participate in the manual round (irrespective of willingness expressed in earlier round if any).**

A candidate who was allotted and admitted in round 1 and wanted upgradation in manual round (who retained seat in round 2 due to non upgradation/ not wanting upgradation/ non filling of choice) is **allowed to participate in manual round.**

The candidates who do not report for admission after being allotted will be out of the counseling process and will not be allowed in manual round of counseling.

The manual round of counseling for Medical and Dental seats will be held at Medical College Kolkata in place of earlier stipulated venue of RGKar Medical College Kolkata due to administrative reasons.

Details of notice for manual round of counseling will be published later on.

Any surrender from seats after 4 pm of 25 August 2017 will lead to bond penalty for the concerned candidate for release of the documents as such seat will not be included in the manual round and such seat will be wasted for the academic year 2017-18 sessions.
