Minutes of pre-bid meeting on 12/10/18 in connection with re-etender for supply of cooked diet vide this office Memo No.-CMOH-Nad/9101, dt.-05/10/18:

The tender selection committee decides that

a) In case of credential:

- 1) If any work of similar nature starts before 1st May, 2011 and spans up to any date 'within the time period from 1/05/2011 to 14/01/2018' (last day before the date of issuance of terms and conditions of tender by the Department), work value of 3 years at most of that work within the time period from 1/05/2011 to 15/01/2018 will be taken into consideration.
- 2) If 'any part of work'/'whole work' of similar nature spans for more than 3 years within the time period from 1/05/2011 to 14/01/2018, work value of only 3 years at most of that work within the time period from 1/05/2011 to 14/01/2018 will be taken into consideration.
- 3) If any work of similar nature starting on/before/after 1st May, 2011, and spans up to any date after 14/01/18, work value of only 3 years at most of that work within the time period from '1/05/2011 to 14/01/2018' will be taken into consideration.
- 4) Proforma for performance statement page and all the pages of performance proving documents need to be notarized properly along with notarial certificate at the beginning.
- 5) It is being reiterated that if any bidder submits TDS as performance proving document that TDS must be issued by the purchaser/end user.

b) In case of bank solvency certificate:

1) If any bidder who has submitted bid in the etender for supply of cooked diet vide this office Memo No.-CMOH-Nad/348, dt.-11/01/18 and submitted correct bank solvency certificate in that etender, wishes to resubmit that bank solvency certificate in this present re-etender for supply of cooked diet vide this office Memo No.-CMOH-Nad/9101, dt.-05/10/18; he/she may do so along with a prayer addressing to the Chief Medical Officer of Health, Nadia for reusing such bank solvency certificate.

However, if a bidder who has not submitted bid in the etender for supply of cooked diet vide this office Memo No.-CMOH-Nad/348, dt.-11/01/18, wishes to submit bid in this present etender, he/she has to submit bank solvency of any date after 05/10/18 (issue date of this present etender notice).

2) In case of partnership firm, Bank solvency certificate must be issued in the name of that firm.

c) In case of bidder's undertaking:

It is being reiterated that in case of bidder's undertaking as mentioned under point No. 13.1 of General Instruction to Bidders of terms and conditions of NIT in question; non-conviction of Proprietor/Promoter/Director, employee, partner(if applicable) or representative must be mentioned.


d) In case of audited balance sheet & profit & loss account:

For audited balance sheet & profit & loss account for last 3 years, along with FY 2014-15, 2015-16, 2016-17; FY 2017-18 may be accepted also.

e) In case of P.Tax registration:

Only P.Tax registration certificate is needed. No P.Tax challan will be considered.

Last but not the least, in case of tender id: 2018_HFW-193087_2 of www.wbtenders.gov.in regarding re-tender for supply of cooked diet for Ranaghat SD Hospital vide this office Memo No.-CMOH-Nad/9101, dt.-05/10/18, in work item details, the location is to be read as 'Ranaghat SD Hospital' in place of 'District Hospital, Nadia' & Pin code is to be read as '741201' in place of '741101'.


