3. In the event of any of the above mentioned dates being declared as a holiday for the e-tender inviting authority, the bids shall be opened on the next working day at the scheduled time.


4. The bid submitted should be addressed to the tender inviting authority, i.e. to the CMOH, Bankura.


6. The e-tender shall be evaluated under the two-bid system, i.e. through evaluation of technical and financial bids uploaded by the bidder online on the e-tender website of <https://wbtenders.gov.in>.

**Terms & Conditions:**

1. The bidder should be reputed & resourceful Manpower Supply Agency having working experience in Govt. Offices or Organization specifically in Govt. Offices of Health Department.
2. The bidder must have the requisite trade and other licenses to do the business of providing health related Services in the hospitals & Office for which the bid is being made.
3. The bidder must not have been blacklisted by any hospital or government organization. An undertaking that the bidder has not been blacklisted/debarred for any reason whatsoever by any Government Department/Organization/Undertaking should be furnished by the bidder in non-judicial stamp paper of appropriate value duly notarized.
4. The bidder must not have been convicted in or have pending in any court any vigilance or any criminal case against it or its proprietors or principal employees.
5. The bidder should a cash reserve equivalent to 4 months of health related Services in the hospitals & Office bills of the hospitals for which the bid is being made. (A self declaration to this effect is sufficient)
6. Valid trade license, PAN card, GST registration certificate, upto date clearance of P.Tax & I. Tax to be accompanied with the bid documents. The organization should be enlisted with Labour Department, Govt. of WB and has to submit a valid labour license.



7. In the event of e-filing intending bidder may download the tender documents from website [www.etender.wb.nic.in](http://www.etender.wb.nic.in) in directly by the help of digital signature certificate and the earnest money of Rs. 10,000.00 only (Rupees ten thousand only) has to be deposited by online RTGS/NEFT or Net banking through ICICI Bank Gateway in the e-tender procurement system (Non-Statutory documents as per the G.O. No. 2365 F(Y) dated 12.04.2018 and G.O. No. 3975 F(Y) dt. 28.07.2016). The Earnest money will be converted to the Security Deposit, when the work order issue to L1 bidder.
8. Credential for services in Govt. Offices & Hospitals for last three financial years to be accompanied with the bid documents.
9. The agency will not be entitled to withdraw the agreement without serving a notice of withdrawal to the Tender Inviting Authority in advance for at least three months.
10. The Tender Inviting Authority reserves the right to terminate the agreement any time without assigning any reason there on and even for non-performance of any clause above after serving a notice of 1 (one) month advance.
11. In case of negligence in performing duty from any personnel, he/she should be removed immediately from duties by the Agency with prior notification to the office of the undersigned.
