- 1) Duration of Lease from **01.08.2022 to 01.08.2025**.
- 2) **The highest bidder of the list will be selected.**
- 3) Organization/person have to deposit the bid amount i.e. above this base price **Rs.2,10,000/-** (Rupees Two Lakhs and Ten thousand only) by Demand Draft(DD) in favour of **Rogi Kalyan Samity, Kakdwip Sub Divisional Hospital.**
- 4) No Chemicals, Environmental Pollutant can be used in the water of pond.
- 5) No other activity other than pisciculture will be allowed. No further construction is allowed. Figure shape of the pond cannot be changed.
- 6) No other person other than the selected tenderee will be allowed to use the pond.
- 7) If any natural calamity/disasters occur the hospital authority can use the water of the pond for public interest purpose.
- 8) Immersion of goddess is prohibited.
- 9) Any damage to the Kakdwip SDH property including beautification should be taken care of by the lease holder. If any damage is observed during the lease period by the Kakdwip SDH authority, lease holder will have to bear the cost damage as estimated by the Kakdwip SDH authority without any objection failing to which lease agreement may be terminated.
- 10) If the contractor's behavior is not found satisfactory and found not abiding the terms & condition of the tender after repeated warning, hospital authority has rights to cancel his tender or contract as per tender rule and also blacklisted him for a period so that he will be disqualified for participating any tender/auction of the corporation.
