NOTICE INVITING EXPRESSION OF INTEREST
(Through two Cover, Cover-A (Techniacal BID) Cover-B(Financial BID)

The Undersigned invites sealed "**Expressions of Interest**" in Two Bid system (Technical BID and Financial Bid) from the prospective agencies for running the garage of Two-Wheelers parking (approximate 2654 SQF) at the Basement of B.C. Roy Casualty Block of R.G.Kar MC&H with the following terms and conditions laid down by the authority.

Terms and Condition:-

1. All the vehicles should be checked for any explosives inside the carrier or elsewhere.
2. The premises should be cleaned regularly- at least twice daily.
3. Every action should be taken to prevent damage to hospital property.
4. All staff having a parking sticker/ parking pass issued by the Principal , RG Kar MC&H should be allowed free parking.
5. Patients' relatives willing to park their Two-wheelers at the parking lot may be allowed to do so with a minimum charge of Rupees ten (Rs, 10.00) per hour.
6. The parking lot should be open round the clock (24 x 7) for the beneficiaries.
7. The successful H1 Bidder should deposit a security money of Rs. 30,000.00 only which will be adjusted in the last month of the contract period.
8. The successful H1 Bidder should deposit a monthly user charges(Base quote Rs. 30,000/-)in advance to the Rogi Kalyan Samiti of R.G. Kar M C H.
9. When operational, the H1 Bidder may take additional imitative to ensure all Two-Wheeler parking inside the campus of RG Kar MCH at the basement only.
10. The said contract would be valid for a period of three months which is likely to be extended on the basis of performances.
11. The security (safety of parked two wheelers against possibility of thefts) of the proposed parking lot establishment would be the responsibility of the successful H1 Bidder for the contractual period. Hence utmost vigil would be sought from the successful bidder.

The last date of submission of quotation is 2.4.2022 on 1 PM and the same will be opened on the same date at 2.00 PM in presence of interested bidder, if any. The bidders will submit the Expression Of Interest in their own official pad along with the following essential documents :

4. P- Tax challan FY.2021-22
