TENDER NOTICE

The Medical Superintendent cum vice principal, NRS Medical College and Hospital, Kolkata-14 invites Tender from the bonafied firms for total cover of CAMC of EPABX System Passive port including 1,2,6,10,20,30,50,100 pairs cable with PVC pipe and all spare parts and accessories (repair of cabling shifting providing new extension of telephone connection and repair old telephone sets for the period from 16-04-2019 to 15-04-2020. In view of above the undersigned invites bid in sealed cover (technical bid and financial bid separately) from interested parties.


The last date of submission of tender is 25-03-2019 at 2.00 pm and technical bid will be opened on the same day at 2.30 PM in the office of the MSVP, NRS Medical college & Hospital, Kolkata. Financial bid of successful bidders will be opened on 29.03.2019 at 2.30pm. The said tender paper/ documents regarding the terms and condition will be available from the Repairing Store of the hospital against payment of Rs.100/- (one hundred) only in cash (non-refundable) to cash section on all working days from 12-03-2019 to 16-03-2019 between 10.00 am to 1.00 pm.,

1) **Earnest money: Five thousand** (Rs. 5000.00) only as Bank Draft from any nationalized bank in favour of payable at M.S.V.P, of N.R.S, Medical College and Hospital Kolkata:-14 payable at Kolkata. The rate should be quoted both figure and words including all applicable taxes & duties. The successful Tenderers shall have to furnish a security deposit of 5% of the total value of the accepted amount in F.D.R from any nationalized bank in favour of M.S.V.P NRS Medical College and Hospital Kolkata:-14 payable at Kolkata and execute a deed of agreement within fifteen (15) days from the date of receipt of the order. The Security Deposit will be forfeited if the tenderer refuses to Sign the contract agreement after approval within the stipulated time.

Terms and Condition:-

- 1) The firm should have at least 03 years experience in maintenance of extension lines in Govt Institution/Departments.
- 2) The detailed postal address of the firm with telephone and e-mail address should be furnished.
- 3) **Interested tenderer may inspect the telephone lines installed at our facility before bidding from 18.03.2019 to 20.03.2019 in between 10.00am to 1.00pm.** No escalation or enhancement in price finalize under the agreement shall be allowed under any circumstances.
- 4) **Scope of Work.**
 - i) Providing new extension of telephone from exchange
 - ii) Maintenance of extension of telephone from exchange.
 - iii) Shifting of Telephone extension (Providing wire etc. if needed)
 - iv) Repair of telephone instruments.
- 5) The firm should put asset number on telephones maintained by them and arrange to put them up in separate register along with details of room /place/building/floor they are placed/located. If any shifting /addition occur they will make the changes in the record accordingly under the supervision of the telephone operator.
- 6) The tender is not transferable and under no circumstances the successful bidder shall be allowed to sub-contract the same to another firm/party.
- 7) The service technician/personnel should take up any reported fault within 24 hours and should provided maintenance and repair service on holidays in case of emergency. The service would be from 9am to 5 pm all working days.
- 8) At the end of CAMC contract period, the firm should certify about satisfactory working condition and that no pending faults or complaints exist.
- 9) The Tenders are to be accompanied with the following papers / documents: -
 - Bank Draft indicating deposit towards payment of E M D
 - Valid Trade license, (Nature of Business)
 - PAN Card,
 - P. Tax certificate
 - GST Registration certificate
 - Credential Certificate.

Payment shall be made on quarterly basis subject to satisfactory services against bills submitted. No advance payment will be made for whatever reason, however quarterly payment after satisfactory completion certificate submission would be made.
