

2. The centre should be situated within half kilometer from Purba Medinipur District Hospital.

4. The centre should be opened for 24 hours per day (i.e. round the clock).
5. The technicians will have valid certificate.
6. The report must have the signature of a doctor.
7. Self attested copy of Valid GST Licence, PAN card, Valid Trade License and First Page of Bank Pass Book (For issuing cheque) to be submitted along with the tender. And all document to be shown at the time of opening of tender in original (If required).
