Bifocal glasses should be according to power (distance & near) prescribed by MT Optometry. PD should be strictly maintained. 3) Spectacle should be providing in a hard plastic box /Case with soft cloth for each. 4)The box/case will have embossed (preferably) /sticker fixed on it on either of the following two (number i is must) or all of the three logos :- i) NPCB & VI, ii) NHM, iii) Biswa-Bangla.
