NOTICE INVITING TENDER

Tender must be submitted in a sealed cover and superscribed with capital letters as "**TENDER FOR SPECTACLES**" to the office of the undersigned. Tender must be accompanied by attested copies of current valid Trade License, PAN Card, GST and Professional Tax clearance certificate along with demand draft of Rs. 1,000.00 (One thousand) as earnest money duly pledged to the Secretary, District Health & family Welfare Samity, Asansol Health District.

The last date of receipt / submission of sealed tenders is **19.11.2018 till 12.00 p.m.** from this end and no tender will be accepted after the stipulated date and time. Tender submitted by registered post/ speed post/ courier will only be accepted.

The Rate should be quoted both in figure and in words for the Spectacles in the format given below. Tender document must be submitted in English Language.

Tender will be opened on **19.11.2018 at 01.00 p.m.** in presence of willing tenderers or their representatives. The selection committee reserves the right to reject or to accept any tender without assigning any reason thereof.

TERMS & CONDITIONS RELATING TO THE TENDER FOR SPECTACLES

Period of Contract: - Tender will remain valid for the financial year 2018-20.

Security Deposit: - The successful tenderers shall be required to deposit the ' Security Deposit of Rs. 3,000.00 (Three thousand) and the same is to be deposited through bank draft duly pledged to the Secretary, District Health & family Welfare Samity, Asansol Health District, & the same will be retained in the office of the undersigned.

The security money will be liable to be forfeited without prejudice to any other action in the event of failure /refusal to do supply works according to the contract.

Risk & penalty: - In the event of failure to supply works as per contract the risk works (purchase of listed items) will be made from other sources. The excess expenditure will be recovered from the failure contractor from any money (Accounts) due to the contractor or any other legal manners.
