1. Tender papers should be dropped in the tender box along with photo copy of -

 - B. Electrical Contractor Licence (2020-21),
 - C. SSC Parts No.1,2,4,7A, & 11 of contractor and Agency,
 - D. Trade License (Renewed 2020-21 F.Y.),
 - E. IT return for the Assessment Year 2020-21,
 - F. GST Registration certificate along with latest chalan
 - G. Professional Tax registration certificate & Latest Professional Tax Chalan,
 - H. PAN Card,
 - I. Signed copy of Estimate,.
 - J. Credential in form of payment / completion certificate including copy of work order of a single work (similar type) executed within five years counted from the date of issuance of this notice amounting to minimum sixty five percent (65%) of the tendered amount
2. The tender documents are to be collected from the office of the CMOH & Secretary, DH&FWS, Tamluk, Purba Medinipur during the period mentioned in Table - 2 of this notice, on payment through Bank draft of any Nationalized Bank in favour of **District Health and Family Welfare Samiti, Purba Medinipur**, Payable at Tamluk amounting to price mentioned in Table - 1.
3. Earnest money, as mentioned in Table - 1, in form of Demand Draft of any Nationalized Bank in favour of **District Health and Family Welfare Samiti, Purba Medinipur**, Payable at Tamluk, will have to be deposited during submission of tender. No interest should be given on the earnest money
4. The bidder whose bid has been accepted will be notified by the Tender Inviting & Accepting Authority through acceptance letter/Letter of acceptance. The notification of award will constitute the formation of the contract. After final selection of agency, a formal agreement may be executed within 7(Seven) days from the date of receipt of the work order with the concerned authority of health institution in a non-judicial stamp paper.
5. The Security money of the successful selected tenderer may be forfeited for failure to complete the work within specified time and/or, for unsatisfactory articles in quantity and quality
6. 3(Three)% value of the work will be retained from the bill as security deposit which will be released after successful completion of 1 years from the actual date of completion of the work.
7. No interest will be paid on security deposit and Earnest money
8. Taxes and Cess will be deducted from the bill as per existing Govt. rules & regulation.
9. Rate should be quoted in percentage basis, both in figure and in words on Estimate copy.
10. Incomplete Tender will be rejected summarily.
11. Before submission of the Tender, contractors must visit /inspect the work site at own cost to judge the local situation /condition, approachable road etc. No plea/complain about the site, approach road etc. shall be entertained afterwards. It shall be presumed that the agency offered the rate after taking into account the entire position of the work site.
12. The offered rate should be inclusive of all charges such as GST etc.
13. No mobilization / secured advance will be allowed.
14. No single Tender shall include more than one work, but contractors who wish to Tender for two or more works shall submit a separate Tender for each.

15. The successful tenderer(s) shall have to start the work within seven days from the date of issuing the work order and the work should be completed in with the stipulated time failing the work order will be treated as cancelled.
16. Acceptance of lowest Tender is not obligatory & the undersigned reserves the right to accept any Tender or to reject any or all without assigning any reason.
17. The undersigned reserves the right to alter the terms and condition of this notice at any time for the interest of public service only.
18. The item of work for which Tender is submitted should be clearly mentioned along with commensurate Earnest Money deposit. The Earnest Money deposited will be forfeited by the Secretary, DH & FW Samiti & CMOH, Tamluk, Purba Medinipur in case:-
 - a) The tenderer withdraws tender after opening or acceptance.
 - b) The selected tender fails to accept order, refuses either wholly or partly the offer that would be made by the undersigned.
 - c) The selected Tenderer fails to work or reply within the date stipulated in the work order.
19. Schedule of work will be prepared and measured as per approved P.W.D (W.B) schedule of Rates, Effective from 1st November, 2017.
20. Contractor should put their firm/organization's endorsement (signature of authorized signatory with official stamp) on each page of the tender document as token of approval.
21. Contractor(s) should note that non-compliance of any of the instruction is liable to render their Tender non-bona fide.
22. All kinds of materials and labour related to the job will have to be arranged by the contractor and must be approved by Engineer in charge or Inspector before their use. The contractor shall remove the rejected materials/ workmanship from site within 24 hours of completion at his own cost.
23. The contractor shall store all helping tools/equipment, which will be used for Electrical Instalation, at his own cost and shall have to carry out work with his own equipment and machinery.
24. The quantities mentioned in the schedule of quantities approximately indicate the total extent of work, but may vary to any extent and some items may even be omitted. No claim whatsoever shall be entertained on this account.
25. If the Engineer in charge/authorized officer of employer finds that the work(s) are being delayed by reason beyond the control of the contractor, the Engineer in Charge will make a fair and reasonable extension of time for completion of the contract with the written approval of the undersigned.
26. The contractor has to obtain certificate about the satisfactory Completion of work from the Engineer in charge/ Appropriate Authority and submit the same along with the bills.
27. Contractors should take requisite "All Risk Insurance Policies" to cover workman under Workman Compensation Act, loss / damage caused by natural calamities / accident / accidental collapse of partially completed work, materials and plant at site and for third party claims for injury / damages.
28. As per GO No 4608-F(Y), Dt. 18.07.2018 from Govt. of W.B. Finance Dept.(Audit Branch), the eligible bidder have to submit Addition Performance Security @ 10% of tender amount if the accepted bid value is 80% or less of the estimate put to tender. The addition performance security shall be submitted in the form of bank guarantee from any nationalized bank within 7 working days from the date of issuance of letter of acceptance, if failed his EMD will be forfeited and other necessary actions like blacklisting of the contractor, etc. may be taken. The bank guarantee will be returned after successful completion of the work. If the bidder fails to complete the work successfully the bank guarantee will be forfeited at any time during the pendency of the contract period after serving proper notice to the contractor.
29. Before taking initiation of any extra item/excess quantity during the work, the same should be approved by Engineer in charge or Inspector.
30. Due to work at Hospital, the Contractors / agencies will be responsible for work at emergency basis and urgently finishing the work.
31. Payment of the work will be made by the office of the undersigned on satisfactory completion of the work to be certified by the Engineering wing of the office of the undersigned after receiving bill from the contractor(s) / agency(s).
