

**Terms and condition relating to Re-tender for collection of halting charges after entry for half an hour of Public Vehicles/Four Wheelers/ Two Wheelers/Three Wheelers/Toto/Rikswa and Rikswa Vans etc. in this hospital premises/compound for the period of one year.**

1. The contract shall remain valid up to **one year** or may be extended as the hospital authority considers suitable.
2. Tenders are to be submitted in their prescribed letter pad with sealed covering letter super scribed "The Tender Memo No : BMCH/ SK-IV....., Dated:....., along with Xerox copy of valid Trade License, Pan card, Income Tax, and GST registration certificate and Demand draft for Earnest Money . The tender must be dropped in the tender box kept in the office chamber of The Medical Superintendent –cum- Vice Principal, B.M.C. & H, Purba Bardhaman as stipulated date and time mentioned in the tender notice.
3. An Earnest Money deposit amounting to Rs.2, 000/- (Rupees: Two thousand) only deposited through **Demand Draft in favor of Medical Superintendent-cum- Vice Principal, B.M.C &H payable at Burdwan** should be submitted along with the tender . Unsuccessful tenderers may withdraw their earnest money when the tender is finalized.
4. Rates should be quoted both in figures and in words. No erasures, insertion and over writing will be entertained.Tenderer will also specify the amount which they will deposit to the account of BMC&H on monthly basis during the validity period of tender. Rates for halting charges after entry for half an hour for different types of Public Vehicles/Four Wheelers/ Two Wheelers/Three Wheelers/Toto/Rikswa and Rikswa Vans etc. as stated here under:-
  - a. **Four wheeler Vehicle Rs:- 20/-(Rupees Twenty) only after entry of half an hour.**
  - b. **Three wheelers Vehicles Rs:- 10/-(Rs. Ten) only after entry of half an hour.**
  - c. **Two wheelers Vehicles Rs:- 10/-(Rs. Ten) only after entry of half an hour.**
  - d. **Rikswa and Rikswa Vans — Rs:- 5/- (Rs. Five)only after entry of half an hour.**
5. If any vehicles (i.e. Public Vehicles/Four Wheelers/ Two Wheelers/Three Wheelers/Toto /Rikswa and Rikswa Vans etc.) halts over half-an-hour has to be paid further halting charges according to same rate.
6. No halting charge will be collected from any Govt. Vehicles/Ambulance at the time of collection of such halting charges. If any dispute arises, then and there the matter has to be brought to the notice of the hospital authority and in this regard the decision of the hospital authority will be final.
7. Bi-cycles owners those who will enter inside the hospital Premises/compound are requested to keep their Bi-cycles in the selected cycle stand against requisite fees of Rs.2/- (Rs. Two) only to avoid hazard.
8. The approved agency will have to deposit the approved & accepted amount on monthly basis to the Account Section of BMC&H after getting work order within 1<sup>st</sup> week of succeeding month positively No delay in deposit of such amount will be entertained.
9. The selected tenderer will have to furnish security deposit amounting to **Rs.-5,000(Rupees Five thousand)** only through **Demand Draft in favor of Medical Superintendent-cum- Vice Principal, B.M.C &H payable at Burdwan**
10. In the event of failure, dissatisfaction or refusal to comply with the instruction noted above will lead to the forfeiture of security deposit
11. The M.S.V.P., B.M.C.H., Burdwan shall be at his liberty to terminate the contract after 10(Ten) days notice in case of failure of execution of work.
12. The agency will look after that no Rikswa, Totos and other Vehicles remain standing within the hospital premises, the agency will be liable for failure to maintain such.
13. Any violation of the rules fix up for the agency may be sufficient for cancellation of the agency.
