The Superintendent Cum Member Secretary, Rogi Kalyan Samiti, Jangipur Sub Division Hospital, Murshidabad invites bids through tender vide Memo No. HFW-27022/54/2019-ADMIN SEC(DHS)(HFW)-Dept. of H&FW/4914 Dated 27/08/2020 of ADHS (Ophth) & State Programme Officer (NPCB&VI) and the order of Chief Medical Officer of Health, Murshidabad vide Memo No. CM/MSD/NPCB/6894 Dated 12/10/2020 and the corrigendum vide Memo No. CM/MSD/NPCB/7198 Dated 20/10/2020 for supply of spectacles for School Children and Old persons (As requisitioned by Ophthalmologist / Mt (Opt.) [onsite delivery with screening] of different size under National Programme for Control of Blindness.

1. Place & date of opening the tender : Office of the Superintendent, Jangipur S.D. Hospital, Raghunathganj, Murshidabad at 2 P.M. on 28/11/2020.
 2. Time Schedule : Tender should be submitted between 11/11/2020 to 27/11/2020. Tender from will collect from the office from 11/11/2020 to 20/11/2020 during office hours.
 3. Technical Specification : The cell frame (Cellulose acetate) should be good quality with spring side and frame should be fitted with face and nose properly and availability of different colour of frame. The lens should be good quality with CR-39 glasses for students and presbyopic patients (scratches & bubbles free), high index glasses of more than 4D power of the students. Bifocal glasses should be according to power. PD should be strictly maintained. Sample of frames and lenses to be preserved for checking.
 4. General terms & condition :
 - a. Defective spectacles detected during handover to beneficiary should be replaced free of cost.
 - b. Three months warranty period for spectacles frame (replace or repair) without any additional cost.
 - c. Optician from the vendors' end will need to remain to present during OPD/outreach sessions and during SES programme sessions for distribution of spectacles to the beneficiaries.
 - d. If any student requires bifocal glass, the vendor will provide the same according to the prescription.
 - e. The vendor will write the power of glasses in a paper.
 - f. Sample of spectacles should be deposited with bid and should be tagged with a slip on which name of firm should be mentioned.
 5. Bidders eligibility :
 - a. Bidder should have PAN card, GST certificate, updated Trade Licence, Professional Tax enrolment certificate and updated Professional tax paid challan. Xerox copy of above enclosed with Bid.
 - b. 1 year experience for supplying of spectacles to any institution.
 6. Rate : The price/rate will be quoted by the bidder in INR and shall remain firm till the completion of contract. It shall be inclusive of all charges and taxes including GST and nothing more shall be added to the quoted price at the time of billing. As per order of Dy. Director Health Services (NCD-1) & State Programme Officer (NPCB & VI) vide Memo No. HFW-27022/1/2018 Dt. 17/05/2018, highest rate may be fixed @ Rs.350.00/per spectacle for school student and old person.
 7. Terms of supply and payment : Payment will be made only after receipt of the items and after completion of all formalities. No advance payment will be made. The firm will be bound to supply the items within stipulated period, failing which the undersigned will cancel the order and agreement.
 8. Penalties : If any information furnished by the bidder/supplier is found to be incorrect during selection or in future, the undersigned will disqualify the bidder/supplier.
 9. Period of Tenure : Three (3) years starting from 01/01/2021 to 31/12/2024.
