2. Items to be supplied must conform to the specification as above. If any deviation is found, the department reserves the right to reject the materials at its sole discretion.
3. Three (3) months warranty period for the spectacles frame (replace or repaired) without any additional cost. **Defective spectacles** detected during hand over to the beneficiary should be changed free of cost.
4. The department reserves the right to reject any or all the Quotation at its sole discretion without assigning any reason therefor.

Self attested copy (Bidder) of PAN Card, GST registration certificate, updated IT Return, Trade License are to be attached positively with the bidding application.

6. Payment shall be made after receiving the materials in good condition and with requisite quality.

7. The rate should be quoted within Rs.350/- including all taxes, delivery charges and other charges as applicable.

8. The successful Bidder will have to deposit of Rs.7500.00 as Security Deposit within 07 working days after opening of bid, in favour of Salanpur Block Health & Family Welfare Samiti, State Bank of India, Rupnarayanpur Branch, A/c No- SB 10935498044, IFSC- SBIN0002114 for the entire contract period and it will be refunded after successful completion of Contract.

9. The selected tenderer(s) will have to supply articles (finished spectacles with box) as per specification approved by the Tender Selection Committee as and when requirement basis and in number through work order(s) issued from time to time by competent authority. The articles are required to be supplied to the concerned health units and educational institutions as will be mentioned in the work order(s) on own expense of the tenderer(s).

10. The successful bidder will be bound to supply the items within specific dates, mention in the procurement order. The timely supply of printed articles will be the essence of contract. The Security deposit of the successful selected tenderer may be forfeited for failure to supply within specified time and/or, for supplying unsatisfactory articles in quantity and quality.

11. Validity of Tender will normally be for 1 year from the date of acceptance of tender. It may be extended up to next 3 years on quarterly / half yearly / yearly basis if situation arises and both parties agrees on same terms and conditions or till the time when the approved rate under NPCB&VI gets changed whichever is earlier.

12. Optician, from the vendors' end, will need to remain present as a mandate during the OPD/Outreach sessions (if is needed so) and during SES program sessions for distribution of the spectacles to the beneficiaries to check its proper fittings etc.

13. If two bidders will quote same price for the finished product, then year of experience / credential will be taken into consideration. If experience will be same then lottery will decide the fate.
