The Technically Qualified agencies must submit above items for verification of Sample pieces as mentioned by SBD to the TIA at the CMOH office Bankura, within the stipulated date & time (Submit before the Financial Opening).


**TERMS & CONDITIONS :-**

- i) The tender may be evaluated separately for each item.
- ii) The items are: as given in BOQ.
- iii) Payment shall be made after receiving goods in good condition and subject to availability of fund.
- iv) Bills in duplicate along with recipient challans is to be furnished to the office of the undersigned for payment.
- v) A 'Purchase Committee' will conduct the whole tender process.
- vi) The intending bidder may download the tender documents from the website [www.etender.wb.nic.in](http://www.etender.wb.nic.in) in directly by the help of digital signature certificate and an earnest money of Rs.10,000 only (Rupees Ten thousand only) has to be deposit by online RTGS/NEFT or NET Banking through ICICI Bank Gateway in the e-tender procurement system (Non-Statutory Documents).
- vii) The Scan Copy of RTGS/NEFT or Net Banking through ICICI Bank Challan from e-tender portal should be uploaded in the file with technical document.
- viii) The Earnest Money will be converted to the Security Deposit, as and when the work order is issued to L1 bidder.
- ix) The Earnest Money will be treated as the Security Deposit as mentioned Rs.10,000 only, for one or more items.


- xi) Valid trade license, pan card, GST registration certificate & upto date clearance of P. Tax and 3 years I.Tax to be accompanied with the bid documents.
- xii) No advance against supply will be allowed.
- xiii) **Rates are to be quoted including all taxes and charges.** Delivery of the items is to be made at the Office of the Chief Medical Officer of Health, Bankura at the own cost of the supplier.
- xiv) The authority reserves the right to reject/cancel any or all quotations without assigning any reason what so ever and is not liable for any cost that might have incurred by any bidder at that stage of bidding.
- xv) Conditional/ Incomplete tender will not be accepted in any way.
- xvi) Rate quoted by the bidder will remain valid for 01(one) year from the date of opening of Bid. The period of validity may be extended if considered necessary under the accepted rates and terms & conditions subject to the satisfactory performance on the part of the bidder.
- xvii) **Items must be supplied within 07(seven) days from the date of acceptance cum work-order issued.**
- xviii) Failure of compliance to supply materials by the selected firms as per sample within the scheduled time will be sufficient ground to blacklist the concerned firm. In this situation the Items will be procured from the next higher bidder or local market and the difference in rate will be deducted from the pending bills or security deposit of the firm failed to supply.

- xix) Bids shall remain valid for a period not less than 120 (one hundred twenty) days from the last date of submission of Financial Bid. If the bidder withdraws the bid during the validity period of bid, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
