Sealed quotation are invited from the Manufacturer/ Direct Importers/ authorized distributor firms for supply of the following items as mentioned below for use of different department(s) under R.G.Kar Medical College & Hospital.

The last date of submission of quotation is **24.09.2021** on 1 PM and the same will be opened on the same date at 1.15 PM in presence of interested bidder, if any. The bidders will submit the quotation in their own official pad along with the following essential documents :

1.Valid Trade License/Enlistment. 2. PAN card of the Bidder/Bidder company. 3.Manufacturing License(in case of manufacturer). 4. GST Registration certificate. 5.IT Return of Last year. 6. Export Import License with JEC code (for Importer).7.Valid P Tax certificate 8. Test certificate in the category BIS/IS/FDA /US FDA or European CE with registration number of the products or products. 9. Credential of the bidder in supply to other Govt. Hospitals. 10. Brochure of the product or products.

The quotation is to be submitted in the drop box which will be kept at the office chamber of the undersigned on all working days from 17.09.2021.

Physical verification of samples and/or Physical demonstration may be done at the discretion of the hospital authority by a team of expert to adjudge the applicability or suitability of the product or products in the functional requirement of the patient since the items are life savings and the technical evaluation will be done accordingly in close observation of the product or products, technical brochures alongwith Test certificate produced and physical sampling thereof.

The undersigned reserves the right to accept or cancel the whole procedure at any time without showing any reason.

Eligibility for Quoting: Only Manufacturers who have manufacturing capacity with desired specification of the product or products or Direct Importers with desired specification of the product or products as specified in the Quotation document.

a. For hospital consumables/ Instrument/medical devices : BIS/IS/ US FDA/ FDA/ European CE certificate of the product or products with proper registration number of the product or products. Test certificate from any other test house is, however subject to the satisfaction of the Expert group. b. The vendors who are blacklisted by any Govt Institutions as a whole or for any particular item/items are not eligible for submitting its tender as a whole or for the said item/items respectively in this tender.

All sterilized products should be BIS/European CE/FDA/US FDA approved and marked (ISI/CE)/approved by US FDA/European CE with registration number. All quoted products should conform to the requirement of relevant national/international quality certifications. Physical verification of samples may follow by the Expert committee for this purpose. Expert Committee(s) thus formed will evaluate the quality and the suitability/applicability of the item to meet the functional requirements of the R.G.Kar Medical College & Hospital across the State alongwith test certificate produced. Equipment found by the Expert Committees to be unsuitable for intended use/ of poor quality/ not conforming to specification & standard test report as provided in the Bid documents will be rejected. The Tenderer offering the item found suitable by the Expert committee to meet the functional requirements for intended use and as per the Quotation specifications and conforms the standard will only be selected.

For Orthopaedic implant and other items, L1 will be determined by cumulative total of the items put to Quotation against a particular Cat no with various sub cat no(s) attached with it. As for example, for DCP Plate, L1 will be determined by cumulative total of the sub cat no attached to it. This is required to avoid mismatching of the Ortho implant and other items vis a vis the accessories within a particular cat no. However, no rate should be quoted for instrument set attached to it which is more clearly described in the BOQ and to be supplied free of cost during operation which can be taken back after operation .
