**TERMS AND CONDITIONS IN CONNECTION WITH HIRING OF VEHICLE ON DAILY BASIS FOR RBSK-KUR, BPHC, SADAR 1 BLOCK, PURBA BARDHAMAN.**

Following terms and conditions are to be followed by the Owner/ Agency.

1. The Car must be holding a valid Registration as Commercial Car conforming **Bharat Stage-IV (Latest Model) and Diesel driven- Non AC** type.
2. The Car should be within three years from the date of manufacture; maker of vehicle should be specified.
3. The Car must be in good and sound condition having **all West Bengal Road Permit, Tax Clearance, PCB Certification** and all other related documents required for playing in the roads.
4. In case of new vehicle, the bidder must submit booking documents and if the bidder is being selected primarily, then he has to submit vehicle details (tax token registration no. & others) certified by RTO within 7 days of selection.
5. The Car must be maintained, clean by the agency/owner regularly and properly. Vehicle must be parked inside the campus.
6. The owner will be liable to deploy Car **as and when necessary**. Punctuality will have to be ensured.
7. The driver of the Car should possess the commercial driving license issued by the RTO or appropriate authority for the class of Car he is driving for a period not less than 5 (five) years and should have a running mobile phone. The Drivers must observe all the etiquette and protocol while performing the duty.
8. No additional payment outside accepted rate is payable for hiring of driver(s) and / or for boarding & lodging of driver (s)/ or cost for repair etc arising due to accident met by the vehicle, if any.
9. In case of any temporary withholding of service of the vehicle for repair/ maintenance/ illness of driver etc by the vehicle owner, substitute vehicle of same quality and/or, alternate driver is to be provided for the period of withholding subject to prior intimation to authority concerned.
10. Reimbursement of POL consumed by the vehicle @ 1(one) litre HSD for 12 KMs and 1(one) litre lubricant (Mobil) for 500 KMs will be made separately to the owner as per existing Govt. norms only.
11. The Car will be engaged on hired basis up to 31.03.2021 or any further instruction whichever is earlier.
12. The contract of hiring can be terminated by the B.M.O.H at any time without any prior notice and assigning any reason thereof.
13. In case of any dispute, decision of authority hiring the car will decide the issue and the decision will be the final.
14. In case of syndicate of transporters /Co-operate of transporters, the valid photocopy of Memorandum of Association shall required to be submitted along with the tender document.
15. No repair charge either in petty or heavy nature due to breakdown of the vehicle during (i)accident,(ii)normal circumstances,(iii)'Bandh' or 'Hartal' shall be given.
16. During accident any compensation to the public for causing injury/damage to (i) any public,(ii) any cattle,(iii) any permanent /temporary structure shall be borne by the contractor himself.
17. The offer in respect of a vehicle registered outside this state will summarily be rejected.
18. Hiring rate of the vehicle should not be exceeded the Gov. approved rate.
