Instructions to Bidders

A. General guidance for e-Tendering:

Instructions / Guidelines for electronic submission of the tenders have been annexed for assisting the suppliers to participate in e-Tendering.

1. Registration of Supplier:

Any suppliers willing to take part in the process of e-Tendering will have to be enrolled

& registered with the Government e-Procurement system, through logging on to <https://wbtenders.gov.in>. The Vendor is to click on the link for e-Tendering site as given on the web portal.

2. Digital Signature certificate (DSC) :

Each supplier is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. DSC is given as a USB e-Token.

3. The supplier can search & download NIT & Tender Documents electronically from WB e- Tender Portal once he logs on to the website using the Digital Signature Certificate. This is the only mode of collection of e-Tender Documents.

4. Submission of Tenders:

Tenders are to be submitted through online in two folders at a time for each supply, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

B. BID Submission of Tenders:

1. Technical Proposal

The technical proposal should contain scanned copy of the following documents contained in two covers (folders).

- IT Return of last three years.
- Trade License
- P-Tax Registration Certificate.

2. Financial Proposal

Quoted discount rate will be encrypted in the BOQ under Financial Bid.

3. Experience / Credential

The prospective bidders should have valid credentials as mentioned in the BOQ prior to the date of issue of this Notice.

1. Body-Inter changeable, inclined Binocular body, 360° rotatable head
2. Eyepieces-Highest quality 10 X wide angle anti fungus field eyepiece.
3. Objectives-Parfocal, antifungus coated 4x, 10x, 40x and 100x (oil immersion) with plan achromatic correction
4. Optical system-Infinity corrected
5. Stage --Horizontal mechanical stage preferably 100 x 140 mm with fine vernier graduations designed with convenient coaxial adjustment for slide manipulation preferably through 30 x 70 mm
