

Eligibility Criteria

1. Bidder or OEM should have valid ISO 9001 Certification.
2. Bidder should have relevant experience in supplying Bio Medical Equipment to Govt Hospitals / Govt Institutions and should provide similar credentials of this kind of work in last 3 Financial years.
3. Bidder should provide Bid specific OEM authorization for each product to ensure their support for this work.
4. Availability of Service Centers: OEM / Bidder must have a Functional Service Centre in Kolkata and have capability of providing service throughout West Bengal. Details of service centre must be provided in ATC.
5. Escalation Matrix for Service Support: OEM / Bidder must provide Escalation Matrix of Telephone Numbers for Service Support.
6. Successful bidder/OEM will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period.
7. OEM and Bidder financial standing: OEM must have an average annual turnover of INR 17 Lakhs in the last 3 Financial Years. Bidder must have an average annual turnover of INR 2 Lakhs in the last 3 Financial Years. Relevant documents must be submitted for both OEM & Bidder.
8. OEM / Bidder must have supplied similar Bio Medical Equipment across Govt. Hospitals / Govt Institutions of a minimum of 20% of the Bid Quantity over the last 3 Financial Years.
9. End user certificate: Bidder/ OEM shall invariably furnish documentary evidence / Client's certificate of at least 3 (three) users of the quoted model in support of the satisfactory operation in India.
10. Bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.
11. As many as number required, end user training must be provided within the warranty period without any charges.
12. Payment: 80 % of the Base Price of the Equipment along with applicable GST shall be paid after delivery and furnishing of Consignee Receipt (asper form-A) along with challan duly signed by consignee. Remaining 20% of the Base Price of the Equipment along with applicable GST shall be paid after successful & satisfactory installation, commissioning and initial end user training by the authorised service team of the supplier and furnishing of Satisfactory Installation report as per form-B.
13. The Purchaser reserves the right to increase or decrease the quantity to be ordered up 4 / 5 to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
14. **Liquidated damages for Delayed Delivery/Delayed setting up of Services:**
The percentage of 0.5% of the Invoice price for each week or part thereof, of delay until actual delivery or performance, up to a maximum deduction of 10% of the Invoice price.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. 3. 4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
