Section-I: GENERAL INSTRUCTIONS TO THE BIDDERS (GIT)

GENERAL TERMS & CONDITIONS FOR DISPOSAL OF CONDEMNED VEHICLES & ASSORTED SCARPS ETC

1. Interested and eligible bidders for purchasing the condemned vehicles, condemned unserviceable Tyres, used engine oil and Ferrous & Non Ferrous assorted scarps as mentioned in the Annexure-A, Annexure-B, Annexure –C & Annexure-D may submit their highest bid in the BOQ.

2. WHO CAN BID

Bidder having the following-

i) **Trade License /Professional Tax/IT Return:**

The responding Bidder should have valid Trade License issued by the competent authority for similar type of works and also valid Professional Tax Certificate & Income Tax Clearance Certificate.

ii) **PAN No. :**

The bidder should have valid PAN (Permanent Account Number) in its name with Income Tax authority in India.

iii) **Goods & Services Tax (GST):** The bidder should have its name in Goods & Services Tax Identification Number (GSTIN) in India.

iv) Annual Turnover of the bidder in the last financial year should not be less than 50 Lakh.

3. EARNEST MONEY DEPOSIT (EMD)

ii) Tender received without EMD, unsigned bids and conditional bids not be considered and not be accepted.

iii) The earnest money will be returned to the unsuccessful tenderer in due course. EMD will subsequently be treated as Security Deposit for successful tenders and will not carry any interest & the EMD will be refunded after successful completion of the condemnation process.

- iii) H1 will be determined on final price only (Excluding GST & other Taxes)

Note:

- Any wrong or misleading information provided by the Tenderer during submission of bids may lead to summary cancellation of bid, blacklisting in SHTO for at least 5 Years and forfeiture of EMD.
- Each scanned documents should have an index page indicating the name of the documents enclosed with Page no.
- The Earnest Money will be refunded after finalization of the tender and/or completion of the lifting of condemned materials process.

7. EVALUATION AND COMPARISON OF BIDS

(A) Technical Evaluation

During the tender evaluation process **Non-Statutory document** (document uploaded in My Space), **Bid – A** constituting the technical bid will be opened first and evaluated. The determination of Technical qualification status of a bidder will be based on the following:

- i) **Scrutiny of Form 1 (NIT Acceptance Form) duly notarized**
- ii) **Undertaking Regarding Blacklisting-Form II**
- iii) **Scrutiny of documentary evidence as per Form 2: Check List.**

A bidder will be considered technically qualified if, Comply with above.

(B) FINANCIAL EVALUATION

Financial Bids (Bid - B) of the technically qualified Bidders would only be opened.

THE DECISION OF THE SHTO AUTHORITY WILL BE FINAL AND BINDING IN THIS MATTER.

(C) Responsiveness of Bids

SHTO's determination of a bid's responsiveness is to be based on the contents of the bid itself.

(D) Financial evaluation:

The financial bids of only those bidders who qualify in the technical bids will be opened.

(E) SHTO's Right to Accept Any Bid and to Reject Any or All Bids:

SHTO reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to Tenderers.

(F) Financial Bid:

Financial bids of the technically qualified bidders will be opened. Award of the Contract will be based on the rates quoted in the financial bid only.

- i) Successful Bidder is liable to lift all those condemned vehicles /assorted scraps /tyres/used engine oil etc with their own expenses and arrangement. SHTO will not be responsible for arrangement of labourer, cranes or other tools/machineries or bear any cost to this effect.
- ii) In case, successful Bidder does not lift the condemned vehicles /assorted scraps /tyres /used engine oil etc within stipulated period of 15 (fifteen) working days after deposition the full sale value then bidder is liable to pay Rs 1000/- (one thousand) per day for each lot up to 15 days towards Ground Rent and after 15 days, the amount deposited with SHTO, Kolkata will be forfeited without any notice and acceptance of offer also to be treated as cancelled.
- iii) In case of applicability of GST or any other taxes at any stage the same is to be paid by the Tenderer and rates offered should include that amount. In no cases GST amount will be deducted from the offered amount.
- iv) The person authorized by the Bidder will be allowed to take delivery and authorized person should have his or her identity proof and official seal.

8 . Other Terms & Conditions

- a. **The Tenderer will bid for the lot in a single price and shall not bid for any particular item.**
- b. Bidders shall quote rates both in figures and words in BOQ, If there is any difference between the rates in figures and in words, the higher of the two shall be considered.
- c. Validity of Rates:- The quotations submitted should be valid a period of 120 days from the date of opening the bids.
- d. The condemned vehicles & assorted scraps will be disposed of on 'AS IS WHERE IS', 'No Complaint' and 'Caveat Emptor' basis only. No guarantee for its worthiness or quality will be given by this Department.
- e. Tender once submitted cannot be withdrawn /modified and any money deposited including EMD shall be forfeited.
- f. The Joint Director of Health Services (Transport), West Bengal reserves the right to withdraw any material from sale at any stage without assigning any reason thereof.
- g. The Joint Director of Health Services (Transport), West Bengal reserves the right to disqualify any bidder at any point of time without assigning any reason thereof.
- h. The Joint Director of Health Services (Transport), West Bengal does not bind himself to assign any reason for non-acceptance / cancellation of the auction.

i. The address of the bidder given in the Tender shall be deemed to be the Bidder's address and correspondence sent on that address shall be considered to have been delivered to the Bidder. No claim will be entertained for reason of forfeiture of the sum deposited, in case correspondence is returned back "UN-DELIVERED"

j. The condemned vehicles /assorted scraps /tyres etc will be allowed to be lifted between 11.00 AM to 3.30 PM on any working day within the stipulated period with prior intimation. No picking, choosing or sorting will be allowed in the premises for the disposal of lots. Whole lot would have been picked up and a receipt for the same will have to be submitted before taking the delivery.

k. Tenderer will have to submit the self-attested photocopy of the valid Trade License, GST, PAN, Professional Tax registration no / Clearance certificate along with the tender, without which the tender will not be accepted.

l. It shall be implied and taken for granted that the party has carefully gone through and understood the terms & conditions of auction including the amendments, if any, prevailing at the time of bid. **No complaint or objection shall be entertained by State Health Transport Organisation after the bid is opened / accepted.**

9. Undertaking Regarding Blacklisting:

- a. The bidder should not have been blacklisted by any Central / State Government / Public Sector Undertaking for the auctioned item(s) and / or any other item. An undertaking in this regard should be submitted by the bidder in the form of Affidavit (Annexure – I), otherwise his bid shall be summarily rejected.
- b. If the selected firm is found / detected Blacklisted by any Central / State Government / Public Sector Undertaking (for the auctioned item or any other item) at any stage of Auction process, the acceptance of the selected bid would be treated as cancelled and the contract in whole will be terminated with immediate effect without any intimation to the concerned bidder.
- c. In case of (b) above the EMD will be forfeited. The decision taken by Deputy Director of Health Services (Transport), West Bengal in the matter will be treated as full & final in this regard.

10. Insolvency / Criminal activities:

In case of partnership/other firm –

- d. None of the partners/owner should be insolvent, in receivership, bankrupt or being wound up and their affairs are not being administered by the Court or a judicial officer, their business activities have not been suspended and subjected to any legal proceedings.
- e. None of the partners/owner should have been convicted of any criminal offence related to professional conduct or of the making of false statement or misrepresentation as to their qualifications.
- f. The act of the breach of performance of the contract by any of the partners shall be binding on the firm.
- g. The bidder shall be construed to mean the prime bidder and all clauses as are applicable to a bidder shall also be applicable to the prime bidder.
