## **TENDER NOTICE FOR CYCLE STAND**


Sealed Tenders are here by invited by the Superintendent, Islampur S.S. Hospital, Uttar Dinajpur from the bonafied firms reputed contractors for collection of halting charges after entry of 4 Hours different types of public vehicles like Four Wheelers/Three Wheelers/Two Wheelers/ Rickshaw Vans/Bi-cycle etc.

The Superintendent, Islampur S. D. Hospital, Uttar Dinajpur, under his administrative jurisdiction inviting expression of interest from eligible bidders for establishment and above mentioned perking stand in front of Islampur S. S. Hospital, Islampur, Uttar Dinajpur, "Sealed Tender" is to be dropped in the specified box kept in the office of the undersigned from 09-07-2021 to 25-07-2021 up to 03-00 P.M. excluding Sunday and Govt. Holidays. The Box Shall be opened on 26-07-2021 at 04-00 P.M. in the presence of the interested bidders.

### **Terms and condition as follows:-**

1. The Contract shall remain valid up to one year or may be extended as the hospital authority considers suitable.
2. Tenders are to be submitted in their prescribed letter pad with sealed **covering letter, Photo Copy of Pan Card, cancelled Cheque/Bank Pass Book**, The tender must be dropped in the tender box kept in the office chamber of the Superintendent, Islampur S.D. Hospital, Islampur, Uttar Dinajpur as stipulated date time mentioned in the tender notice.
3. Rates should be quoted both in fingers and in words. No erasures, insertion and over writing will be entertained. Tender also specify the amount which they will deposited against the Government account annually during the period the tender.
4. Rates for halting charges after entry of form hour for different types of public vehicles/Four Wheelers/Three Wheelers/Rickshaw vans etc. as stated here under.
  - a) Four wheeler Vehicle Rs 20/- (Rupees Twenty) only after entry of four hour.
  - b) Three wheeler Vehicle Rs 10/- (Rupees Ten) only after entry of four hour.
  - c) Two wheeler Vehicle Rs 10/- (Rupees Ten) only after entry of four hour.
  - d) Rickshaw/Rickshaw Van Rs 10/- (Rupees Ten) only after entry of four hour.
  - e) Bi-Cycle Rs 5/- (Rupees Five) only after entry of four hour.If any vehicles (i.e. Public Vehicles/Four Wheelers/Two Wheelers, Three wheelers Rickshaw & Rickshaw Van etc.) Halts over four hours have to be paid further halting charges according to same rate.
5. No halting charges will be collected from any Govt. Vehicles /Ambulance at the time of collection of such halting charges. If any dispute arises and there the matter to be brought to the notice of the hospital authority and in this regard the decision of the hospital authority will be final.
6. Approved agency will have to deposit the accepted or approve amount at a time to the account section of this hospital after finalization of the tender and acceptance of the approved letter by the agency within the stipulated time, No delay in deposited of such amount will be entertained and approval me by cancelled.

7. Minimum Ceiling Rate Rs 99000/- (Rupees Ninety Nine Thousand) Only per annum.
8. The Selected tender will have to furnish security deposit amount of Rs 9900.00(Rupees Nine Thousand Nine Hundred) only through Demand Draft in favour of "**Rogi Kalyan Samiti Islampur S D Hospital**" payable at Islampur duly pledged to the Superintendent Islampur, Uttar Dinajpur.
9. In the event of failure, dissatisfaction or refusal to company with the above noted instructions then the security deposit will be forfeited.
10. The Superintendent, Islampur S D Hospital, Uttar Dinajpur shall be at his liberty to terminate the contract after 10(Ten) days notice in case of failure of execution of work.
11. The agency will see that no Rickshaw and other vehicles remains standing within the Hospital premises then the agency will be liable for that.
12. Any violation of the rules fix up for the agency may be sufficient for cancellation of the agency.
